

## TERMS AND CONDITIONS "REEF RICHES" PROMOTION

### PROMOTIONAL PERIOD

1. The "Reef Riches" promotion ("**Promotion**") commences on Friday 25 October 2020 and ends on Friday 12 February 2021.
2. The promotional period ("**Promotional Period**") during which participants are entered or are eligible to enter the Promotion commences Tuesday 29 December 2020 and ends on Friday 5 February 2021.

### ELIGIBILITY

3. Entry into the Promotion is only open to persons who are 18 years of age or over, who reside in Australia and are current financial Members of Canterbury-Hurlstone Park RSL Club who have the CHPRSL Insignia App ("**Eligible Entrants**").
4. Directors, management and employees of Canterbury-Hurlstone Park RSL Club, Bargo Sports Club, Magpie Sports and their immediate families are not eligible to participate in the Promotion.
5. Members who have been excluded from Canterbury-Hurlstone Park RSL, Bargo Sports Club or Magpie Sports are not eligible to enter the Promotion.

### PARTICIPATION

6. To enter Eligible Entrants will be required to log onto the CHPRSL Insignia App daily from Tuesday 29 December 2020 to Friday 5 February 2021 and play the Reef Riches Game ("**Game**").
7. Eligible Entrants can play the game up to five (5) times a day and have the chance to win up to five hundred (500) entries a day.

### DRAWS

8. Draws take place at 8:00pm Friday nights from the 8 January 2021 to 5 February 2021. ("**Draw Days**")
9. Members will be required to Check In ("**Check In**") their entries at the Members Kiosk ("**Kiosk**") by swiping their card at the kiosk and pressing the 'Check In' button each draw day between 12:00pm-8.00pm. If a member does not check in then their entries will not be included in the draws.
10. One (1) Entry will be drawn from the pool of 'Checked In' entries via the Player Elite Drawing System and will be announced via the Public Address system at Canterbury-Hurlstone Park RSL Club.
11. The drawn entrant ("**Drawn Entrant**") does not have to be present.
12. A push notification will be sent to the winner and all members who have the CHPRSL Insignia App at the conclusion of each draw notifying them of the winner.
13. Prizes available 50,000 Loyalty Points each draw.
14. Eligible entrants can win multiple times during the promotion.
15. Entries will not accumulate over the entire promotional period and at the conclusion of each draw the barrel will be emptied. All entrants will start at zero (0) at the conclusion of each draw.
